People or relatives detained by ICE in the jails of Bergen, Monmouth, Sussex or Hudson in New Jersey can call for advice and possibly representation. Detained people (or relatives) in other jails can call for advice online.

Immigrant Representation Project:

People who are not detained but have pending cases in immigration court can go to 26 Federal Plaza 12th Flr, Room 1207. Services are available one week a month from Tuesday to Friday, from 9-11am. Call 212-577-3300 for exact dates.

CAUTION: People with prior orders of deportation and undocumented people without a pending case are put at risk if they go to 26 Federal Plaza.

Immigrant Defense Project:

212.725.6422: It's best to call Tuesdays and Thursdays in the afternoon if possible. This service is for people who have criminal cases pending and need advice about how charges can affect immigration status.
