#### TRUST FUNDS SUMMARY

Members should feel secure knowing their Pension Fund is currently 107.1% funded and the Medical/Welfare Fund has reserves of over 24 months as of the end of the 2018 calendar year, while trustees continue to focus on improving benefits to the membership.

#### MESSAGE FROM BUSINESS MANAGER

#### **MIKE PROHASKA**

I am proud to report that our local worked an all-time record amount of 12.5 million hours this past year. This is a result of the collective hard-work and dedication of our membership.



Local 79 members can now look

forward to another year of improved benefits. After assessing our pension's financial solvency, the trustees and I decided to put the surplus funds into our members' pockets. Starting January 1<sup>st</sup>, most journeyworkers are eligible to see an increase in their pension accrual rate from \$12.50 to \$14.00 per credit when they retire. Additionally, we earmarked another 25 cents for each member's annuity due to surpluses in our training fund.

We also have taken steps to protect the well-being of retiree health benefits. Most recently, we instituted a new rule beginning April 1<sup>st</sup> that a new retiree is eligible for health benefits only if they have 20 plus years of credited service and were an active member for 7 of the last 10 years. This new rule has no direct impact on active retirees, except for the assurance that our funds will continue to provide quality health coverage to our membership.

It brought me pride and sorrow to announce George Zecca's retirement at our last membership meeting. George is a true friend to many of us and is widely known as a dedicated and true leader. He leaves our union well prepared for continued prosperity and I am confident all in new Executive Board positions are up to the task.

Despite the strength of unions in New York, there is trouble brewing in our nation's federal courts with new anti-union justices appointed by President Trump. For a long time powerful corporate interests have been waging political warfare against us and have turned their focus to the judicial branch. Reversing previous precedent, the National Labor Relations Board ruled in January that SuperShuttle drivers were independent contractors and not able to organize a union. These rulings pose a direct threat to workers' ability to exercise their 1st amendment rights and organize through collective action. Remember, elections have consequences.

This is a pivotal time in our country, but I am not afraid, because we control our own destiny. "Count Me In" and other worker-led movements throughout the country are sending a strong message that when we unite together in solidarity we can overcome any foe that stands in our way. Thanks to members like you, Local 79 continues to be the greatest local in the greatest city in the world.

## DEMOCRATS CONTROL STATE, PUBLIC WORKS BILL EXPECTED

In a resounding victory, Governor Andrew Cuomo and New York Democrats took control of the State Senate in the November elections for the first time since 2010. Thanks to the efforts of Local 79 members, we now have many pro-labor



elected officials with proven track-records of fighting for worker rights in the highest offices of our state.

One of the most current important pieces of legislation introduced is the Public Works bill. This legislation was not passed in the last Republican-controlled Senate but is now a clear priority for the legislature with many sponsors in both the Senate and Assembly.

On January 9<sup>th</sup>, the opening day of the state capitol, hundreds of rank-and-file "Count Me In" Building Trades activists took over the building and demanded public responsibility for public money. Our members know that the expansion of prevailing wage will deliver justice to thousands of working-class construction workers that build projects tied to taxpayer money. We expect to see legislation passed by the state budget deadline on April 1<sup>st</sup>.

In the weeks before the last election, Business Manager Mike Prohaska reminded the membership, "Everyone must decide what is most important. When I was sworn in as a Business Manager, I made an oath to grow and strengthen this union. My personal feelings about any issue take a backseat to my union book. We need to do what we have to do for our union so that we can put food on our tables."

## MAJOR CONTRACTOR SIGNED, APPRENTICES AID ORGANIZING


The construction market is reaching astronomical levels. "Still," commented President Anthony Vita, "we know that boom markets do not last forever. That is why our organizers and business agents are hitting the streets all over the city and protecting our jurisdictional work."

In a major victory, we reached an agreement with Suffolk Construction, a major non-union general contractor, to become part of the Building Contractors Association of New York.

Over the years, Local 79 has been instrumental in putting millions of dollars of stolen wages in workers' pockets. Our worker outreach efforts counteract

exploitation and educates the larger workforce about the power of the union in improving conditions.

One recent initiative started by Local 79's Organizing Department is to work with new apprentices that have recent non-union construction experience. After talking to an Eastern Region organizer, apprentice Derrich Huggins decided to file a complaint and eventually received a



check for \$4,100 for violations of the NYC Paid Safe and Sick Leave Law by his former non-union employer.

If you know anyone experiencing exploitation as a nonunion laborer, educate them about our apprenticeship program and tell them to reach out to our Organizing Department at 212-465-7912.
