totaling over 3,500 residential units. These projects represent the most recent successes in our union's organizing campaign for the creation of union jobs and affordable housing for our members in the communities where we live. Fifty percent of all units created will be at affordable rents including specific allocations for seniors, veterans and the homeless along with the provision of much-needed community space and services. Local 79 members from these neighborhoods joined organizers to collect over 5,000 petitions to support our vision for these projects. "We rallied, we marched, we organized, and we lobbied tirelessly," said Business Manager Mike Prohaska. "It's a big win for our members, their communities and for all of New York City." Throughout the process, Local 79 was heralded for our consensus-making role in finding sensible solutions in negotiations between developers, council members and community activists.

Carlos' Law Signed by Governor Hochul

Carlos Moncayo's death at 161 Maiden Lane was entirely preventable and the maximum fine for the non-union employer held responsible for his death was \$10,000. From day one, our union held vigils

for workers like
Carlos and we rallied
in their memory
calling for killer
contractors to be
held accountable.
As Francisco Moya,
the original sponsor
of the bill and now
councilmember,



said: "New York should be built by the sweat not the blood of NYC construction workers." Our union worked with Moya and subsequent sponsors, Senator James Sanders and Assemblymember Rodneyse Bichotte Hermelyn, to build support for the bill throughout the state. On December 23, 2022 Governor Hochul signed the bill into law increasing the penalties for criminal corporate liability for the death or serious physical injury of an employee up to \$500,000. "Construction is an inherently dangerous business. But it doesn't have to be a deadly one. On our jobsites, we protect the workers. We thank all those involved for standing up for the non-union construction workers who needlessly lost their lives due to corporate greed," said Vice President Chaz Rynkiewicz.

Williamson Returns, Montalvo Retires

At our December meeting and Holiday Party, the Local 79 Executive Board announced Anthony Williamson's return to Local 79 as a Business Agent and reinstatement to his role as Auditor on the Executive Board. Anthony's recovery from his battle with cancer is an inspiration to all. We look forward to continue fighting with him on the frontlines for union jobs and serving our community. His return

is testament to Anthony's determination and the importance of our union's healthcare.
